INTRODUCTION

This course will focus on the economics of international commerce along with looking at the various shipping industries and how they all contribute to the economy. Students will gain an understanding of the importance of international commerce and how the airlines, shipping companies, and trucking companies work together to move products to where customers need them. Students will learn how international commerce affects the economy and its importance to national and local governments. This course will make it clear to students the supply-chain difficulties experienced around the world during the covid-19 pandemic and how the transportation industry did what it could to alleviate those difficulties. This course will examine air cargo alliances, market characteristics, flight and ground operations, distribution and marketing, and pricing and revenues. This course will cover everything from basic accounting to high-level finance and economics.

How international commerce works through various modes of transportation continues to be an important part of international commerce. Students working in any sort of business dealing with goods and services will be impacted by this in their careers now and increasingly so in the future. As consumer demand increases, more products will need to move across the globe to satisfy that demand. This course will be beneficial for all students in nearly all goods and services industries. This will prepare students to know what to expect and how to further their industry through these different forms of international commerce.

COMPETENCES

Explanation of competences to develop in the course. They can be divided into general and specific. Three or four are enough.

General Competences (GC):

GC1: An ability to apply the techniques, skills, and modern management tools to perform business related tasks.

GC2: An ability to apply knowledge of mathematics, science and/or applied science to ensure safe and

efficient Operations of International Business.

GC3: Knowledge of contemporary aviation, transportation, and commerce industry issues.

Specific Competences (CE):

SC1: Develop an ability to apply and interpret financial information and understand the trends in finance and economics within business and commerce. SC2: Develop the ability to distinguish between appropriate financial and statistical reporting, accountability in finance and responsibilities of financial managers. SC3: Develop a broad understanding of how economic principles apply in business and the transportation industry and an understanding of financial documents used by the industry.



METHODOLOGY

This course will be made up of classroom lectures, visits to Madrid Airport, videos, and written homework and quizzes/exams.

PREPARATION FOR CLASS

- Students will need to read all the articles and book chapters related to the topic before coming to class. While in class, student should show preparation of the readings by asking relevant questions and making comments related to the topic.
- Student should think about questions and relations of the texts with other previous knowledge. Write comments and reflections related to the readings, which can be shared in class to start debates and discussions.
- Student takes notes during class presentation and discussions.
- Student should participate in all class activities in and outside of the classroom.

EVALUATION

• Activities out of the classroom.

It is recommended to assign a percentage of the final grade to those activities outside of the classroom, to make sure that students participate in them. These are visits to organizations, day trips, and others.

Total 30%.

• Exams.

Total 40%.

If the teacher finds out that the student has copied in the exam, the final grade will be 0, without the possibility of making up for the exam.

The teacher can do "surprise quizzes". These are at the beginning of the class and short (about 5 minutes). These can be considered as an classroom exercise.

• Written work.

It is recommended to give students a rubric so they know how this work will be assessed. Total 10%

Note: teacher can deduct points from the work if the student turns in the written work late. It is necessary to say how many points each day.

• Oral presentations.

It is recommended to give students a rubric so they know how this work will be assessed. Total 10%.

• Participation.



High participation is when students are attentive in class, they ask relevant questions, make comments and answer questions posed by teacher and other students. Their attitude shows interest and they are active taking notes.

Low participation is when students seem bored or uninterested, don't ask questions, don't make comments and almost never participate in debates, discussions or answer questions from the teacher and other students.
